# CORRESPONDENCE:

### Clerk:

Wills reported that the American Rescue Plan Act forms have been reviewed by the state. There were a couple of errors that have been corrected and the forms were resubmitted.

# REPORTS:

## TREASURER'S REPORT:

Wills gave the Treasurer's report for Stover. Current checkbook balance is \$178,799.52.

A donation was received from Plan B and money was received from the college for their half of the cost to repair College Drive.

A motion was made by Leyrer and seconded by Welder to approve the treasurer's report. Motion carried.

#### CLERK'S REPORT:

Wills presented a list of expenses for the month. Total expenses reported was \$10,570.10

A motion was made by Leyrer and seconded by Welder to approve the Clerk's report and pay the monthly expenses. Motion carried.

### PLANNING COMMISSION:

Leyrer reported that their last meeting was on September 20. The commission was asked to look into drafting an ordinance to oversee short-term rentals. His advice was that a formal complaint would need to be presented to the township board and the board could then direct the commission to look into it. The suggestion was to cover rentals that are less than 28 days and to cover the whole township not just a particular area. The issue was tabled until the next meeting.

### COMMISSIONER'S REPORT:

County Commissioner, Adam Petersen, gave an update on county business. The budget resolution has been approved and the redistricting map has been approved for commissioner districts. As a result of the new census, the districts were re-drawn and the number of commissioners will be reduced to seven members starting next year.

#### **ZONING REPORT:**

Dale was absent due to illness. There is only one property left on the inspection list. Any new locations will be discussed at the next meeting.

# **Donation Suggestion**

It was suggested that the board consider using the donation money from Plan B to purchase new chairs for the hall. A portion of the hall rental fees have also been set aside for new chairs. It is estimated that the cost will be about \$30 per chair. The board will look at this topic at the next meeting so prices can be obtained and the total of available funds can be determined.

## CITIZENS COMMENTS:

Dave Cooper: Does the board know when the road maintenance will be done on Lakeside Drive.

The Road Commission is waiting until mid-October when traffic will be lighter as lake residents will have gone South for the winter.

Mary Baez: As owner of the mud bog, she invited Mr. Millard to come to the next bog event and see what goes on there. All money collected is donated to the community. Mud bogs are held only twice a year and are normally done by 5 or 6 p.m. She is sorry that it disturbs people; it is not there intent to create problems

Bruce Jorgensen: Reported there is a sewer advisory meeting schedule for October 23. Todd Sattler, the Drain Commissioner, attended the Derby Lake Association meeting in September and explained to the residents that a debt service may be added to the sewer billings to help cover the cost of bond interest. Because so many assessments have been paid off early, there will be a shortfall when the bond payoff is due. He says the amount could be only \$25 per year.
